## CONTRACT AGREEMENT

THIS AGREEMENT made on the 4<sup>th</sup> day of June, 2021 between the Local Government Unit of Gerona, Tarlac of the Philippines, represented by the undersigned ENGR. ELOY C. ECLAR, Municipal Mayor, Gerona, Tarlac (hereinafter called "the Entity") of the one part and RAMGO INTERNATIONAL CORP. of 540 RGC Compound Jenny's Avenue Maybunga, Pasig City (hereinafter called "the Supplier") of the other part:

  - (b) the Schedule of Requirements;

  - (e) the Special Conditions of Contract; and
  - (f) the Entity's Notification of Award.
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
